OCTOBER SPEAKER—WOUNDED WARRIOR CAPTAIN CHARLIE PLUMB

Captain Charlie Plumb has lived what he believes to be the American Dream. As a farm kid from Kansas, he fantasized about airplanes although he felt certain he would never have the opportunity to pilot one. It would be the United States Navy who afforded Plumb the opportunity to live out that dream.

After graduating from the Naval Academy, Plumb completed Navy Flight Training and reported to Miramar Naval Air Station in San Diego where he flew the first adversarial flights in the development of what would be called The Navy Fighter Weapon School, currently known as "TOP GUN". The next year, Plumb's squadron the Aardvarks launched on the Aircraft Carrier USS Kitty Hawk with Fighter Squadron 114 to fly the Navy's hottest airplane, the F-4 Phantom Jet. Code names Plumber, Charlie Plumb flew 74 successful combat missions over North Viet Nam and made over 100 carrier landings. On his 75th mission, just five days before the end of his tour, Plumb was shot down over Hanoi, taken prisoner, tortured, and spent the next 2,103 days as a Prisoner Of War.

Following his repatriation, Plumb continued his Navy flying career in Reserve Squadrons where he flew A-4 Sky Hawks, A-7 Corsairs, and FA-18 Hornets. His last two commands as a Naval Reservist were on the Aircraft Carrier Coral Sea and at a Fighter Air Wing in California. He retired from the United States Navy after 28 years of service.

To this day, Captain Plumb continues to fly left-seat at every opportunity. He has personally owned 8 airplanes, the most treasured being a WWII PT-19 Open Cockpit Antique. He currently owns a Rutan—designed experimental single engine Long-Eze.

The military aircraft he has flown are; T-34 Mentor, T-2 Buckeye, F-9 Cougar, F-11 Tiger, F-4 Phantom, A-4 Sky Hawk, A-7 Corsair, FA-18 Hornet and an F-16 Falcon.

Aircraft Carrier assignments included; USS Constellation, USS Lexington, USS Oriskany, USS Kitty Hawk, USS Coral Sea, and the USS Abraham Lincoln.

Medals & Decorations include; The Silver Star, 2 Purple Hearts, the Bronze Star, Legion of Merit, POW Medal, Air Medals, Combat Action, Unit Citation, Republic of Viet Nam Campaign, and Service Medal.

Since his return home, more than 4,500 audiences in nearly every industry have been spellbound as Captain Charlie Plumb draws parallels between his P.O.W. experience and the challenges of everyday life. He has shared his message to an even wider public through appearances on Good Morning America, Nightline, Larry King Live, and The News Hour with Jim Lehrer.

One of the most sought-after achievement speakers of his time, Charlie Plumb's presentations are as he is, sincere, straightforward, humorous, and tailored to motivate each specific audience he encounters. His insights on how to cope with the difficulties as well as the opportunities in life have a positive impact on those who hear his message, those who read his books, and those who come to know him as a friend.

CASSAR COLOR GUARD PRESENTS COLORS

On September 28, 2013, the CASSAR Color Guard led by Commander Jim Fosdyck and assisted by James Gill (Harbor Chapter), Phil Hinshaw (San Diego Chapter), and Spencer Knock (Silicon Valley Chapter) presented the Colors at the USS Bennington's 25th Reunion and 50th Anniversary of the USS Bennington being home ported in Long Beach, California. The reunion was held aboard the majestic Queen Mary moored in Long Beach.

USS Bennington (Gunboat No. 4/PG-43) was a

member of the *Yorktown* class of steel-hulled, twinscrew gunboats in the United States Navy in the late 19th and early 20th centuries. She was the first U.S. Navy ship named in honor of the town of Bennington, Vermont, site of the Battle of Bennington in the American Revolutionary War.

USS *Bennington* (CV/CVA/CVS-20) was one of 24 *Essex*-classaircraft carriers built during World War II for the United States Navy. The ship was the second US Navy ship to bear the name for the Revolutionary War Battle of Bennington. *Bennington* was commissioned in August 1944, and served in several of the later campaigns in the Pacific Theater of Operations, earning three battle stars.

Let Freedom Ring – National Bell Ringing Ceremony

A NSSAR National Color Guard Event

On July 4th 1776 our Nation was born in a single day when delegates to the Continental Congress from all thirteen colonies assembled at Independence Hall, in Philadelphia, Pennsylvania, and voted to adopt the Declaration of Independence. Afterwards, at 2 o'clock in the afternoon, the Liberty Bell was rung announcing the signing of the Declaration of Independence, that our people would "assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them" and founded upon the proposition that "all men are created equal, that they are endowed by their Creator with certain un-

alienable Rights, that among these are Life, Liberty and the pursuit of Happiness." Since then, every generation of Americans has celebrated the 4th of July as our Nation's birth.

On the Centennial Anniversary of our Nation's birth the Sons of the American Revolution was conceived when on the 29th day of June in 1876 an article was placed in a local San Francisco newspaper calling for "the descendants of the revolutionary fathers" to meet. This group of men, all of them descendants of the men who served in the Revolutionary War, met and on July 4th 1876 formed the Sons of the Revolutionary Sires. The society which they formed later became the Sons of the American Revolution on 22 March 1890.

On the 26th day of June in 1963 both houses of the United States Congress adopted Resolution Number 25 commemorating July 4th as a Day of National Celebration in recognition of the signing of the Declaration of Independence. The words of Resolution Number 25 are;

Whereas the tolling of the Liberty Bell at Independence Hall, Philadelphia, Pa., at 2 o'clock in the afternoon of the 4th day of July, 1776, proclaimed the signing of the Declaration of Independence; and Whereas the adoption of this historic document marked the birth of our country as a free and independent nation; and Whereas it is fitting that the anniversary of this great event should be appropriately observed in each year at the same moment throughout the United States;

Now, therefore, be it Resolved, that the Congress hereby

(1) declares that the anniversary of the signing of the Declaration of Independence should be observed each year by the ringing of bells throughout the United States at the hour of 2 o'clock, eastern daylight time, in the afternoon of the 4th day of July, or at such other time on that day as may be determined by local authority, and (2) call upon civic and other community leaders to take appropriate steps to encourage public participation in such observance."

For 50 years now Resolution Number 25 has been observed as the "Let Freedom Ring – National Bell Ringing Ceremony" and the Sons of the American Revolution have been participating in Let Freedom Ring in various locations across America for many

years. This year, 2013, marks the 50th anniversary of Let Freedom Ring and to date the event has grown to over 10,000 participants and with each passing year more communities join in the observance. Let Freedom Ring is celebrated in cities, towns, and hamlets all across America Let Freedom Ring is also observed at American Memorials and Overseas Military Cemeteries, as far away as France, and by American Merchant Marines at sea and at port.

The above photo was taken at the City of Cerritos, California, 40th Annual Let Freedom Ring Celebration on July 4th 2013. This is the second consecutive year the Orange County Chapter, California Society, SAR; (OCCSAR) Lee's Legion Color Guard has presented colors at the City of Cerritos - Let Freedom Ring Celebration. OCCSAR Vice President, Daniel Shippey, with his Lady, Kelly, appeared in character as General George and Martha Washington. General Washington read the Let Freedom Ring Proclamation and rang the bell with the Mayor, City Council Members, and other dignitaries.

Since July 4th stands as a day of prominence for America and for our Society, members of the Orange County Chapter thought it fitting that a proposal be drafted and submitted to the NSSAR National Color Guard Committee to adopt Let Freedom Ring as a NSSAR National Color Guard Event in honor of our Nation's birth.

A proposal was drafted and co-sponsored by California Society Color Guard Commander, James Fosdyck, and Pennsylvania Society Color Guard Commander, Donald Tressler. Compatriot Karl Jacobs, from the Harbor Chapter, presented the proposal to the NSSAR Color Guard Committee at the

Fall Leadership meeting in Louisville, Kentucky. Upon his return from Louisville, Compatriot Jacobs stated, "I returned yesterday evening and wanted to let you both know that the National Color Guard Committee, National Society Sons of the American Revolution has unanimously approved the Let Freedom Ring - National Bell Ringing Ceremony" resolution as a National Color Guard Event - and participation by Compatriots throughout our Nation is highly recommended and may be counted as attendance at a National Color Guard Event for qualifications to the NSSAR Color Guard Medals..."

CAESAR RODNEY


Caesar Rodney was born on October 7, 1728 on his family's farm, Byfield, on St. Jones Neck in East Dover Hundred, Kent County, Delaware. His parents were Caesar and Elizabeth (Crawford) Rodney and his Grandfather was William Rodney who came to America in 1680s. William had been Speaker of the Colonial Assembly of Delaware Counties in 1704. With an 800 acre working farm his family was considered wealthy by standards of the day. With the purchase of adjacent property, the Rodney's became members of the local gentry.

In 1745 having already reached the age of 16, Caesar's father passed away. Nicholas Ridgely was made his guardian by the Delaware Orphan's Court. Like his father Nicholas Ridgely had dabbled in politics which helped young Caesar to move into that arena. In n1755 he was elected Sheriff of Kent County and served three terms from October 1,1755 to October 2, 1758. From 1758-1759 he served as Justice of the Peace from New Castle.

Politics in Delaware in the 1700s was broken up into two factions. You had the "Court Party" and the "Country Party". The Court Party tended to consist of Anglican and had a strong foothold in Kent and Sussex Counties. They worked well with the proprietary Government and were in favor of reconciliation with the British government.

The Country Party which was in the minority, was largely Scots from Ulster, and was centered in New castle County. They quickly advocated for independence from Britain. Though members of the Anglican, Kent County Gentry, Caesar and his brother Thomas were constantly aligning themselves with the Country Party. They were in a definite minority in Kent County. Rodney worked with Thomas McKean from New Castle, working in opposition to George Read.

During the French & Indian War (1756-1763) he received a commission as Captain of the Dover Hundred Company in Col. John Vining's regiment of the

Delaware Militia. While a Captain he continued to serve in the Delaware assembly from 1761-1765, was a delegate to the Stamp Act Congress of 1765 along with friend Thomas McKean, then returned in October 1765 to the Assembly. Here he continued to serve until October 20,1774.

He served as a delegate to the first Continental Congress from August 2, 1774 to March 16, 1775. He returned to the 2nd Continental Congress in 1775 serving another 7 months before returning to the Delaware's Assembly as it's speaker. He was back with the second Continental Congress from October 1775 – November 7, 1776.

During this time Rodney also served as Speaker of the Delaware Assembly. On June 15, 1775, Rodney presided over the debate for separation from Great Britain with his friend Thomas McKean leading the debate on the floor. The assembly voted to sever all ties with the British Parliament and the king.

Due to his military experience from the French and Indian War Rodney was made a Brigadier General of Delaware's militia. With Delaware's move from self government to independence, the situation deteriorated for the loyalists in Kent and Sussex Counties. There were those who continued to speak out on maintaining their ties with Britain, yet Rodney and the Militia were constantly being called to suppress the insurrections. Loyalists were arrested and jailed, but some did escape to the swamps or British ships.

In late June while attending to loyalist activity in Sussex County, he received a message from Thomas McKean that he and George Read were deadlocked on the vote for independence. In order to break the deadlock Rodney rode 70 miles through a thunderstorm on the night of July 1, 1776 and arrived in Philadelphia on July 2nd, just as the voting was beginning. Breaking the tie between McKean and Read, Rodney voted for the Declaration on Independence. This made 11 states in favor of the separation from Great Britain. The document was approved on July 4th and on August 2 Rodney with the rest of the members signed the document.

Due to his efforts to declare our independence there was a problem back home in Delaware when he was not elected to a seat in the State Constitutional Convention.


Since he was not serving in any office in early 1777 when he learned that his friend John Haslet had died at the Battle of Princeton, Rodney proceeded to join General Washington briefly, but was returned to Delaware by the General as a Major– General of the Delaware Militia. In this position he protected the state from any British military encroachments and was able to control the continued Loyalist activities, particularly in Sussex County.

In September of 1777 the Battle of Brandywine took place. Besides the defeat by the British at the battle things in Delaware were made more troublesome as the President of the State John McKinly had been captured and taken prisoner. With McKinly out of the picture and George Read in bad health and exhausted, Caesar Rodney was elected President of Delaware from March 31,1778 to November 6, 1781

Rodney worked hard to locate supplies and help the war effort. The Delaware Continentals had done their unit proud in several battles including the Battle of Long Island and the Battle of Monmouth. In 1780 they were resoundingly defeated at the Battle of Camden where the Delaware Regiment was nearly destroyed and those who survived had to join the Maryland regiment for the remainder of the war.

With is health deteriorating and having served through the Battle of Yorktown, Rodney resigned from office on November 6, 1781.


With the passage of the Articles of Confederation Rodney was again elected to represent Delaware in Congress in 1782-83, but his ill health prevented him from attending. He was subsequently elected to the 1783/84 session of the Legislative Council. As a final gesture of respect, the Council selected him as their speaker and met as his home due to his declining health. He passed away before the session ended.

Rodney's poor health was due to a cancerous condition of his face. He wore a green scarf to cover it up. Though he had been advised to seek treatment in Great Britain, his stand on independence prevented him from traveling to do so.

He passed away at his plantation on June 26, 1784 at the age of 55. He was buried in the cemetery at Christ's Church in Dover, Delaware.


