SPEAKER

Hammond Salley introduced our speaker Steve Snyder. Steve is the Author of "Shot Down" a story of his dad's WWII experience as a bomber pilot. Shot down over Belgium and of his survival as one of five of a ten man crew. Spoke on his father's time in the military and how he got into flying. He spoke on the liberation of Belgium and the memorial to his dad and his crew. After answering several questions, Steve was presented with a Certificate of Appreciation for speaking to us today.

BUSINESS/REPORTS

The minutes had been emailed out earlier this month. John Dodd moved that they be accepted, the motion was seconded by Lou Carlson. The motion passed.

Treasurer Don Carlson reported we had as of January 1st \$5,597. He reported the form for State and Federal Governments had been filled out and sent in. The Ben Franklin took in a record \$265 today.

Jim also mentioned the upcoming Patriot's Day Parade on Saturday March 5th.and that he had information for those who we interested in joining in the fun.

Registrar Kent Gregory spoke on our new and supplemental members in the last month.

Sergeant-at-Arms Danny Cox spoke had no report.

Chaplain Richard Adams was absent so there was no report.

Color Guard Commander Jim Fosdyck reported on the Massing tomorrow, The Laguna Beach Patriot's Day Parade and the Field of Honor as upcoming events for our color guard.

Veteran's Affairs Chairman Hammond Salley spoke on the finding that long time member Herman R. Keitzman, as reported by Jim Blauer, had moved recently to Yukon, Oklahoma and that he had never received any certificate from his participation in WWII. As the Fosdyck's will be in the area they plan to stop by and present Compatriot Keitzman with his Military Service Certificate.

Compatriot Salley mentioned the list of veterans we have in the chapter and is compiling a list of those who have joined the Veteran's Corps of the SAR. He will be contacting those who have yet to join this group within the SAR.

He mentioned the 50th anniversary of the Vietnam War and the Certificate from the society for those who served during the era, their spouses or families of MIAs. Reserves and National Guards also count. One does not have to be an SAR member to get one of these Certificates.

JROTC/ROTC Chairman Gus Fischer reported that we had 2 entries in the Enhanced JROTC Contest this year. The winner was a lady from Santa Ana High School and Gus hopes to have her here in March to be recognized.

Medals & Awards Chairman Jim Fosdyck asked that if members have received certificates and they do not need their folder to please bring them to him for reuse as they cost us \$1.00 each. It will save us money.

Eagle Chairman Jim Blauer reported that we had 2 entries in the Eagle Scout Scholarship Contest last year and that Jesse Martin was the unanimous choice as the chapter winner. Jim Called Jesse up who read his essay to the assemblage. Compatriot Blauer then presented Jesse with the patches for entering the contest. Compatriot Blauer noted that one of the patched was no longer produced and as such is considered antique and collectable. Jesse also received a check for \$100 from the chapter. Finally Compatriot Blauer requested that Jesse's mother come forward to pin the winner's medal on her son. Following all this Compatriot Blauer requested that any other Eagle Scouts in attendance to please come forward at which time a picture was taken of three Eagles, Compatriots Blauer and Phil Hoge with Jesse. It was also noted that Jesse's application was sent on to state for that part of the contest. It was reported that Jesse was selected as the winner of the State Contest so we will see him in Sacramento in April to receive his state awards. His application has been passed on to the National Society for selection for the big money on that level.

The High School Outstanding Citizenship Contest was mentioned by Jim Fosdyck. The award goes to a member of the Senior Class.

Dan Henry and Hammond Salley presented the SAR Military award to John DePoy and Fred Brockmiller and Wounded Warrior David Calef received our Wounded Warrior Coin and Certificate. All three veterans received quilts from Quilts of Valor by Barbara Winkler.

Hammond Salley asked Phil Mitchell to come forward and presented Phil with the Vietnam Veterans Medal.

New member Scot Trodick was then sworn in as our newest member by President Ferris and was pinned with the SAR Rosette by his sponsor Kent Gregory.

Two supplemental Certificates were presented to James Townsend for his ancestors Wingate and Talbot, Sr.
